Announcements

Election Season

It is that time of year again, so I thought I would include so information about the positions and responsibilities coming up for election.

All officers shall be members of the corporation who hold a valid FCC amateur radio license. The President, Vice-President shall hold a valid Technician or higher FCC amateur radio license. The Emergency Coordinator, Training Coordinator must hold a valid General or higher FCC amateur radio license

Club Officers and their responsibilities are as follows

President

The President shall be the Chief Executive Officer of the Corporation; shall preside over all Corporation and Executive Board meetings; shall be responsible for conducting all Corporation business in accordance with the Articles of Incorporation, By-Laws, and the policies set forth by the Executive Board and membership.

Vice-President

The Vice-President shall assist the President in the performance of his duties in the case of temporary absence. The Vice-President shall also be responsible for securing and organizing Corporation general membership meeting programs and presentations.

Secretary

The Secretary shall record the minutes of all Executive Board and Corporation meetings; shall conduct correspondence related to the Corporation business as directed by the President; shall maintain an orderly file of the minutes of all meetings and other Corporation documents as designated by the President. The Secretary shall also keep the Articles of Incorporation, By-Laws and minutes of the meetings and have the same at every meeting. He shall note all amendments, changes and additions to the By-Laws and Articles of Incorporation and shall permit these records to be consulted by members upon request.

Treasurer

The Treasurer shall collect all monies; shall maintain an orderly accounting system which shall include all Corporation assets; shall submit a complete financial report to the membership at the end of each term of office and at other times as directed by the President or Executive Board; shall

dispense monies as directed by the Executive Board and membership; shall maintain such records and submit and report such as are required by local, county, state or federal taxing authorities; and shall maintain a current record of Corporation membership.

Training Coordinator

The Training Coordinator shall direct and organize all training programs authorized by the Corporation.

Emergency Coordinator

The Emergency Coordinator shall direct all Corporation activities related to communications nets, City, County, State or Federal Emergency Management, RACES, ARES, or any other emergency type activity in which the corporation may become involved; and shall coordinate the Corporation's participation in the ARRL Field Day event.

Editor

The Editor shall be responsible for assimilating, publishing, and disbursing the Corporate bulletin via mail or electronic mail to the Corporate membership.

There you have it! If you would like to run for an office or nominate someone for office (you must have the persons permission to nominate them), please contact any board member, the Nominations Coordinator (should be named at the club meeting), or do so during the call for nominations, at the club meeting.

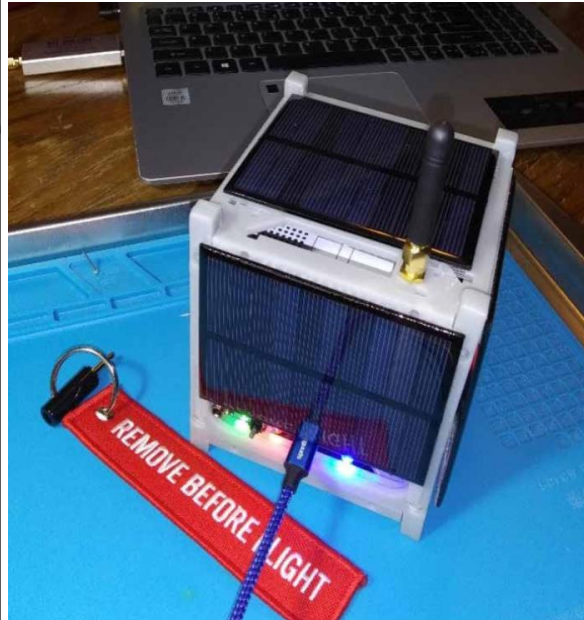
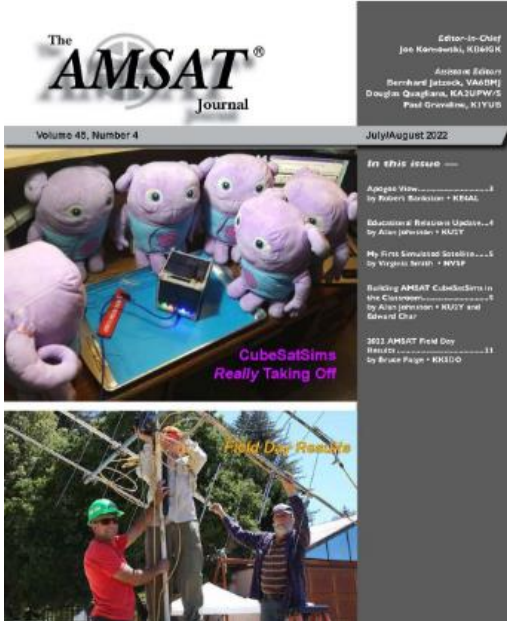

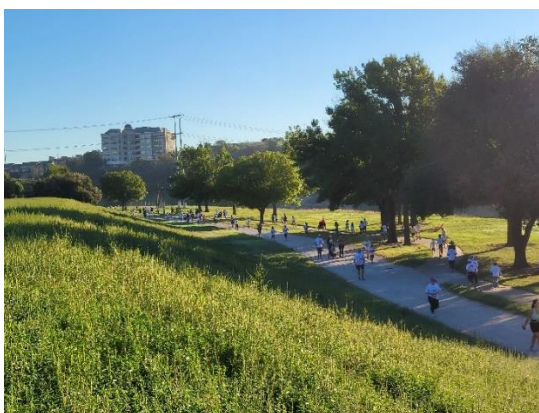
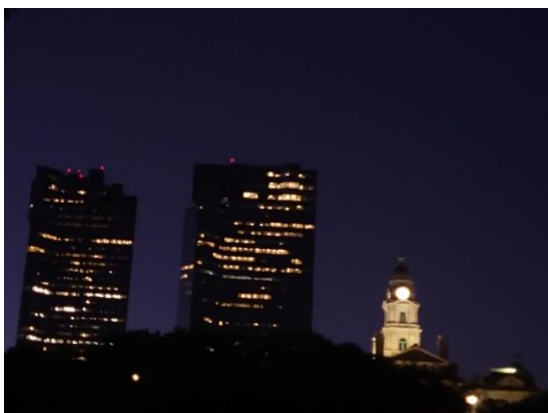
Since the last meeting the temperatures were supposed to drop. This would make running and walking events more tolerable. Well, one out of three is better than zero out of three.

The American Heart Walk was on September 24th. Though Fall officially began, official does not apply to Texas. Morning temperatures in the 70s by race end it was in the upper 80s.

I was at the split for 1-mile and 5K routes. The wall of people coming at the start was fun to watch. The road was not baracaded. It was amazing how many drivers saw the sign for the race and wanted to turn into the oncome crowd of walkers and runners. Fortunately, none of the drivers got visibly upset.



Like all of these events, radio operators have to be onsite at between 5 AM and 6:30 AM with 5:30 AM being the usual time. Photo of downtown Fort Worth well before the sunup. I used to work a few floors down from the top of the tall building in the center. I was a pee on. Still, a lucky one with a corner office, a magnificent view, floor to ceiling windows on two sides. This was a truly Fall event with temperature in the 50s around dawn. I felt rather chilly down along the river while wearing two layers of long sleeve shirts.



October 15th the temps were in the mid-60s. Comfortable for me but not a good start for those doing the 65-mile bicycle ride. It was around 90 degrees at 1 PM. This was something of a factor for slowing some people, but bike mechanical problems kept the sag wagons busy. A few slow riders had to be swept off the course because they were not going to finish any time close to the expected end of the event.

I got to shadow the Logistics person. A lot of walking kept me awake. The fun and sometimes challenging part was the amount of radio traffic passed on rider updates, water stop needs, and their closings. Glad I had pen and paper to keep notes. I need to get a small notebook with a hard cover for writing. We were using a repeater in Cedar Hill with good coverage for the area of the event. Unfortunately, I kept having to walk away from my official to transmit. My handy talkie does not have the power to go through a solid metal building.

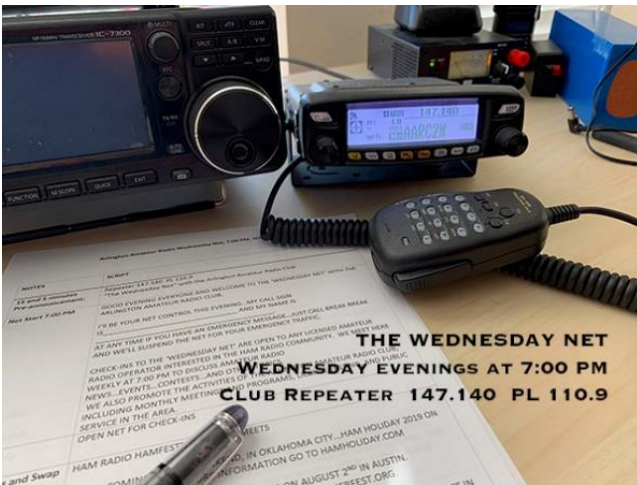

Meeting Minutes

September 2022 Membership Meeting Minutes submitted by Andy Kapushoc KB2VQA, Secretary

The regular meeting of the membership of the AARC was called to order on September 16th, 2022, at 7:30 pm by the President, Jack AA5VZ, accompanied by a teleconference simulcast. Other board members present included Vice President, Philip KD5WBW; Secretary, Andy KB2VQA; Treasurer and Repeater Trustee, Maurice KM5RF; Training Coordinator and Agent of Record, Phil N5PWW; and Editor, Trey AF5XS.

Absent was Emergency Coordinator, Bill AE5BT.

Jack AA5VZ called the meeting to order, and asked attendees to introduce themselves by name and call sign.

Jack AA5VZ thanked those who brought ice cream, desserts, and show-and-tell items to last month's meeting, making it a success. He provided the Irving ARC with a letter confirming the micro-grant funds were used to purchase the new electrical generator that was used during Field Day.

Jack mentioned two upcoming events. Officer elections will be conducted at the November meeting, and he looking for a club member to volunteer for the role of Nominating Committee Chair. The Christmas party will be held in December, at which time the Ham of the Year will be announced. David K5NN will have the responsibility of collecting the ballots via email and in person at the club meeting.
